- Insulation: Typical bulk insulation products qualify including batts, rolls, blow-in fibers, rigid boards, expanding spray and pour-in-place.
- Air sealing products: Typical air sealing products qualify including weather stripping, spray foam in can designed to air seal and house wrap.
- New windows, skylights and doors: Products must be ENERGY STAR® certified. Not every window, door or skylight in the home must be upgraded to qualify.

- Offer is available on a first-come, first-served basis and expires when rebate funds are depleted.

- Complete and submit the rebate form on the reverse side, according to the directions and include specified purchase documentation.
