Professional Weatherization

The most cost-effective way of making your home more energy efficient and comfortable, often starts by making improvements to the building shell – adding or improving insulation and sealing hidden air leaks and drafts.

ELIGIBILITY:

- A savings of 50% off your purchase with a maximum rebate of \$800. Rebate will be provided in the form of a bill credit once approved.
- This rebate is available only to members of Hancock-Wood Electric Cooperative. Improvements must be installed on a HWE member's property.
- Must receive professional installation of insulation products on an existing home between Jan. 1, 2026, and Dec. 31, 2026.
- Room additions do not qualify.
- Home must be heated electrically with geothermal, heat pump/dual fuel or another electric source.
- Structure walls must achieve a minimum of R-16 for exterior wall; R-38 for attic; R-10 exterior basement walls, and R-10 crawlspace w/6-mil poly.
- Complete the rebate form and submit a copy of your receipt from a professional installer stating the R-value in the walls, attic, or crawlspace.
- Must provide original receipt to get credit for purchase.

HOW TO PARTICIPATE:

- Complete and submit the rebate form on the reverse side, according to the directions and specified purchase documentation.

EXPIRATION:

- Offer is available on a first-come, first-served basis and expires when rebate funds are depleted.
